	The Review Applicant has filed this application under Rule 18 of the

	for review and setting aside the judgement and order dated 28.09.2021 of this							
	Tribunal passed in Original Application No. 24 of 2021 inter alia on the ground							
	that case of applicant is fully covered in Category E, (b), (c) & (i) of the policy							
	letter dated 31.01.2001, therefore, the applicant is fully entitled for war invalid							
	pension. The order reads as under:-							
	"9. We have gone through the policy on grant of War Injury Pension							
	and we are of the view that the applicant's case is not covered under							
	War Injury Pension category i.e. Category E of the above policy lette							
	Further, the applicant was suffering from disability due to stress and							
	strain of service while serving in operational areas which is not covered							
	under Category E of ibid policy. Hence, applicant is not entitled to War							
	Injury Pension.							
	10. In view of the above, the Original Application is devoid of merit							
	and deserves to be dismissed. It is accordingly dismissed."							
	It is a settled proposition of law that the scope of the review is limited							
	and until it is shown that there is error apparent on the face of record in the							
	judgment and order sought to be reviewed, the same cannot be reviewed.							
	For ready reference, Order 47, Rule 1 sub-rule (1) of the Code of Civil							
	Procedure, 1908 is reproduced below :-							
	"1. Application for review of judgment (1) any person considering							
	himself aggrieved-							
	(a) by a decree or order from which an appeal is allowed, but from							
	which no appeal has been preferred,							
	(b) by a decree or order from which no appeal is allowed, or							

(c) by a decision on a reference from a Court of Small Causes, and who, from the discovery of new and important matter or evidence which, after the exercise of due diligence, was not within his knowledge or could not be produced by him at the time when the decree was passed or order made, or on account of some mistake or error apparent on the face of the record, or for any other sufficient reason, desires to obtain a review of the decree passed or order made against him, may apply for a review of judgment to the Court which passed the decree or made the order."

In view of the principles of law laid down by the Hon'ble Supreme Court in various decisions, it is settled that the scope of review jurisdiction is very limited and re-hearing is not permissible. The Hon'ble Supreme Court in Para 9 of its judgment in the case of *Parsion Devi and others vs. Sumitri Devi and others*, reported in (1997) 8 Supreme Court Cases 715, has observed as under:-

"9. Under Order 47, Rule 1 CPC a judgment may be open to review inter alia if there is a mistake or an error apparent on the face of the record. An error which is not self- evident and has to be detected by a process of reasoning, can hardly be said to be an error apparent on the face of the record justifying the court to exercise its power of review under Order 47, Rule 1 CPC. In exercise of the jurisdiction under Order 47, Rule 1 CPC it is not permissible for an erroneous decision to be "reheard and corrected". There is a clear distinction between an erroneous decision and an error apparent on the face of the record. While the first can be corrected by the higher forum, the latter only can be corrected by exercise of the review jurisdiction. A review petition has a limited purpose and cannot be allowed to be "an appeal in disguise."

We have gone through the judgment and order sought to be reviewed and no illegality or irregularity or error apparent on the face of record being found therein, we are of the view that there is no force in the grounds taken in the review application so that order may be reviewed.

In the result, Review Application is rejected.

We have gone through the order dated 16.09.2021 of this Tribunal in R.A. No. 01 of 2020 with M.A. No. 31 of 2020 by which application for condoantion of delay in moving review application was dismissed. In spite of dismissal of delay codonation application, we have rejected the Review Application No. 01 of 2020 on merit which reads as under:-

"Learned counsel for the applicant has submitted in his review application that RMB ignored the two more disabilities (i) Acute Bronchitis and (ii) Epididymorchis. On perusal of record, it transpires that these disabilities were cured. Moreover, we have gone through the judgment and order sought to be reviewed and no illegality or irregularity or error apparent on the face of record being found therein, we are of the view that there is no force in the grounds taken in the review application so that order may be reviewed.

In the result, Review Application is also dismissed."

Since the Review Application for review of Judgment and order dated 27.03.2019 passed by this Tribunal in O.A. No. 495 of 2017 has already been dismissed, another Review Application for review of said order being is barred under Rule 18(4) of the Armed Forces Tribunal (Procedure) Rules, 2008 is liable to be dismissed as such.

With regard to review of order dated 16.09.2021 passed by this Tribunal in Review Application No. 01 of 2020 with M.A. No. 31 of 2020, it is a settled

proposition of law that the scope of the review is limited and until it is shown that there is error apparent on the face of record in the order sought to be reviewed, the same cannot be reviewed.

For ready reference, Order 47, Rule 1 sub-rule (1) of the Code of Civil Procedure, 1908 is reproduced below:-

- "1. Application for review of judgment.- (1) any person considering himself aggrieved-
 - (a) by a decree or order from which an appeal is allowed, but from which no appeal has been preferred,
 - (b) by a decree or order from which no appeal is allowed, or
