Counsel for the respondents.</p> <p>Aggrieved with plural marriage contracted by her husband, Ex Hav Krishan Pal , Respondent No 7 and inaction on part of Respondents No 1 to 6, the applicant has filed the instant Original Application under Section 14 of the Armed Forces Tribunal Act 2007 for grant of following reliefs:-</p> <ol style="list-style-type: none">(i) To quash letter dated 23.03.2021 issued by Respondent No 4.(ii) To direct respondent sNo 1 to 6 to take disciplinary action against Respondent No 7 for contacting plural marriage.(iii) To issue direction to Respondents Number 1 to 6 to initiate GCM proceedings against Respondent No 7 for contacting plural marriage.(iv) To take action against Respondents No 1 and 2 for inaction on their part on taking disciplinary action against Respondent No 7 for contacting plural marriage. <p>Learned counsel for respondents No 1 to 6 has raised a preliminary objection regarding maintainability of OA saying subject O.A. including reliefs claimed therein, are not cognizable under the Armed Forces Tribunal Act, 2007. Her submission is that there is nothing against applicant in the letter dated 23.03.2021 of Respondent No 4 giving cause to applicant to seek its quashing. The applicant has only been informed about recovery of arrears of maintenance allowance by this letter.</p>

Regarding reliefs No 2 and 3, her submission is that these reliefs have become redundant with superannuation of respondent No 7 w.e.f. 30.06.2021, and with regard to relief No 4 her submission is that Respondent Nos 1 and 2 can in no manner be held responsible so that action may be taken against them for inaction.

In regard to objection raised in respect of relief Nos 2 and 3, we are satisfied that these reliefs have become redundant due to retirement of respondent No 7 with effect from 30.06.2021. No disciplinary proceedings, including GCM, can be initiated in respect of an ex soldier. Therefore, O.A. is not maintainable in respect of these reliefs. However, as regards relief Nos 1 and 4, there is no such bar in AFT Act, 2007 that they are not cognizable under this Act. We are further of the view that if any of the reliefs claimed in O.A. is cognizable, O.A. may be admitted for hearing.

Accordingly, O.A. is admitted for hearing.

Notice need not be issued to respondent Nos 1 to 6 as they have received it. They are directed to file counter affidavit within four weeks.

Issue notice to respondent No 7 who may also file counter affidavit within the aforesaid time.

Rejoinder affidavit, if any, may be filed within two weeks next thereafter.
