A copy of the same has been produced today in the Court by learned counsel for the respondents. The relevant operative portion of said judgment is quoted below:-</p> <p><i>"56. In summation, we, therefore, find that the instant O.A., so far as his claim vis-a-vis Respondent No. 5, who has been promoted as Major General, is concerned, is devoid of any merit and deserves to be dismissed and that the order dated 04.12.2017 impugned herein stands. Ordered accordingly. Furthermore, both the orders passed by the Regional Bench, Lucknow dated 11.01.2018 and dated 18.04.2018 stand vacated. We direct the respondents to grant Respondent No. 5 his due substantive rank as approved by the competent authority from 01.01.2018. Needless to state that the benefits so accrued to Respondent No. 5 shall also flow to his legal heir(s). We also hold that the applicant is eligible to be considered for promotion to the rank of Major General along with other candidates in the next Board to be held in October 2018.</i></p> <p><i>57. The O.A. stands disposed of accordingly. No order as to costs."</i></p> <p>Since the O.A. has already been finally decided, therefore no useful purpose would be served in keeping this Contempt Application pending.
