Heard arguments of learned counsel for the parties on the bail application.</p> <p>2. In this case, the applicant was tried by the Summary Court Martial for the charge under Section 69 of the Army Act, 1950 read with Section 354 of Ranbir Penal Code. The charge against the applicant was as under:</p> <p style="text-align: center;"><u>“CHARGE SHEET</u></p> <p><i>The accused Number 14825933X Naik/Mechanical Transport Gyaneshwar Prasad Pandey of 618 Transport Company Army Service corps type ‘C’ is charged with:-</i></p> <p>Army Act <u>COMMITTING A CIVIL OFFENCE, THAT IS TO SAY, USING</u> Section 69 <u>CRIMINAL FORCE TO A WOMAN WITH INTENT TO OUTRAGE HER MODESTY, CONTRARY TO SECTION 354 OF RANBIR PENAL CODE.</u></p> <p style="text-align: center;"><i>In that he,</i> <i>At field, on 14 July 2017 at about 1600 hours, used criminal force to</i> <i>Miss ‘X’, aged about 10 years by touching her breast and private</i> <i>parts,</i> <i>intending thereby to outrage her modesty.</i> <i>Place: Field</i> (Ashok Panwar) Lieutenant Colonel Officer Commanding Dated 04 May 2018 618 Transport Company Army Service Corps Type ‘C’.</p> <p><u>“To be tried by Summary General Court Martial”</u></p> <p>Station: Field (SK Upadhya) Dated: 17 MAY 2018 Lieutenant General Commanding General Officer 14 Corps.”</p> <p>3. Learned counsel for the applicant has submitted that the</p>

punishment awarded to the applicant was reduction to rank, to suffer one year's R.I. and to be dismissed from service.

4. It is submitted by the learned counsel for the applicant that the total punishment awarded to the applicant is for one year's R.I. and the applicant is in continuous custody from June 2018, therefore, he has already served out about 50% of the punishment awarded to the applicant.

5. Learned counsel for the respondents has argued that the offence has been committed on a minor girl, therefore, the applicant does not deserve bail.

6. Since the applicant/appellant has already served out more than half of the sentence inflicted on him, therefore, without expressing any opinion on the merits of the case and also keeping in view the fact that the applicant/appellant has already served out about half of the period of sentence imposed by the SCM, we find it to be sufficient ground to suspend the execution of the sentence during the pendency of the instant appeal and to release him on bail. We find substance in the submission of the learned counsel for the appellant that in case the applicant is not granted bail, then his appeal shall be rendered infructuous.

7. Accordingly, this application is allowed and the execution of sentence is hereby suspended.

8. The applicant/appellant Nk Gyaneshwar Prasad Pandey shall be released on bail on his furnishing a personal bond of Rs.50,000/- (Fifty Thousand) with two sureties each in the like amount to the satisfaction of the Registrar of this Tribunal. On furnishing sureties, as stated above, Registrar shall then issue the release order, which in turn will be conveyed to the concerned Jail Superintendent, wherein the applicant/appellant is presently confined serving out his sentences.

9. After the release of the applicant/appellant, the bail bonds furnished for his release, shall be kept on record with the main record.

10. M.A. aforesaid stands disposed of accordingly.
