“11. The applicant’s counsel has canvassed for constitution of a Review Medical Board to assess the fitness of the applicant for his reinstatement in military service placing reliance on Regulation 143 of the Defence Service Regulations (Part-1). We notice that, the above Regulation enables a defence personnel invalided out of service in low medical category to make a request to the competent authority for constitution of a Review Medical Board once he has been relieved of the disability for his invalidation, to have his reinduction in military service. Competent authority receiving such request may or may not constitute a Medical Board, and a decision thereon, no doubt, has to be taken looking into the totality of the facts and circumstances invalided in the invaliding out of service of the maker of such request. It is open to the applicant to make a request before the competent authority for having a Medical Board to assess his fitness for reinduction over the merit over which we express no opinion at all.

12. In short, the challenges raised by the applicant impeaching the validity of his invaliding out of service due to Alcohol Dependency Syndrome (ADS) are shown to be devoid of any merit, and the O.A. is dismissed.

In pursuance to said order, the applicant has preferred representation dated 16.03.2016. Thereafter, the applicant has again submitted a reminder on 25.11.2017. However, the representation is still pending and no decision has been taken by the competent authority.

In view of the aforesaid facts, we disposed of the present O.A. with a direction to the respondents to decide the representation of the applicant dated 16.03.2016 by a speaking and reasoned order with due communication to the applicant within four months from the date of production of a certified copy of this order.

O.A. is disposed of accordingly.\
