We feel that the respondents are continuously shifting their stand and are trying to mislead the Tribunal due to following reasons:-

- (a) This is an execution application for order passed by this Tribunal on 21.02.2017 i.e. one and half years back.
- (b) This execution application was filed eight months after the order i.e. on 19.12.2017.
- (c) The respondents have sought repeatedly adjournments on 22.12.2017, 12.02.2018, 23.03.2018 to comply with the order.
- (d) The respondents have finally submitted on 27.04.2018 that in pursuance of court order dated 12.02.2018, required documents of applicant have been forwarded to PCDA (P), Allahabad on 26.03.2018 and the PPO shall be issued shortly.
- (e) The respondents have again stated on 05.07.2018 that the required documents are with PCDA (P), Allahabad & PPO will be issued shortly. On this date a cost of Rs 15,000/- was imposed on respondents for delay.
- (f) On the next hearing i.e. 10.08.2018, the respondents have again taken a stand that required papers are with PCDA (P), Allahabad since 26.03.2018 & the PPO will be issued shortly. On this date an additional cost of Rs 20,000/- was imposed for undue delay in issuance of PPO.
- (g) In today's hearing the respondents have taken a new stand and submitted that a letter dated 31.08.2018 has been issued to petitioner to produce necessary documents with correct name and date of birth.

This whole sequence of events indicates a non serious attitude on the part of respondents in executing the order of this Tribunal, hence we pass following directions:-

- (a) Provide evidence with details of what papers were forwarded to PCDA (P), Allahabad on 26.03.2018 and when and by which office it was received at PCDA (P), Allahabad.
 - (b) What action has been taken by PCDA (P), Allahabad/what correspondence has been done on this matter by Record Office with PCDA (P), Allahabad after 26.03.2018.
 - (c) At what stage and date and by which agency it has been discovered that the applicant's name and date of birth is wrong and when did Record Office learn about this new development. Produce evidence for the same.
 - (d) Produce evidence of letter dated 31.08.2018 addressed to petitioner for demanding documents relating to name and date of birth and the nature and mode of despatch of this letter.
 - (e) Produce all letters of correspondence between AFT Legal Cell and the concerned record office on this matter since 19.12.2017.
- List this case on **22.10.2018** for orders.

In the mean time, cost shall also be deposited by learned counsel for the respondents in terms of order dated 10.08.2018.
