As per office report, there is delay of 13 days in filing the application for leave to appeal. Section 31 (2) of the Armed Forces Tribunal Act 2007 provides that the application for leave to appeal shall be made for approaching Hon'ble Supreme Court within a period of 30 days beginning with the date of decision of the Tribunal.</p> <p>In view of this, the application for condonation of delay cannot be entertained and it is hereby rejected.</p> <p><b><u>M.A. No 2001 of 2018</u></b></p> <p>This application for grant of leave to appeal, having been moved by the applicant-respondents beyond the statutory period of 30 days.
