Now the innocuous prayer of the applicant is that the respondents may be directed to conduct the Re-assessment Medical Board of the applicant.

Therefore, with the consent of Ld. Counsel for the parties, we hereby **dispose off this Original Application** with the direction to the respondents to conduct Re-assessment Medical Board of the applicant within a period of four months from the date of receipt of certified copy of this order.

It is made clear that in case applicant is held entitled to the disability pension after his Re-assessment Board then he shall be entitled for the disability pension only with effect from the date of conduct of Re-assessment Medical Board.

The claim of the applicant is that the applicant should have been released only after conducting Release Medical Board.</p> <p>Ld. Counsel for the respondents has vehemently opposed the submission made by the Ld. Counsel for the applicant and submitted that for SHAPE-1 only Release Medical examination is required . He has drawn our attention to Army Order 3/89. Para 1 of the said Army Order reads as</p>

under:-

“1. All ranks are required to be medically examined by a medical officer prior to release, retirement, discharge, completion of tenure or service limit or release/discharge at their own request vide paras 391(a) and 418(e) of RMSAF, 1983. Such medical examination will be conducted by the authorised medical attendant (RMO/Staff Surgeon) and the report will be recorded on the form AFMSF-18 in quadruplicate. The OC unit will ensure that the individual is medically examined by the medical officer or brought before a medical board prior to release. If an individual is proceeding on LPR this may be conducted before the proceeds on such leave. The individuals who are in SHAPE-1/Category ‘A’ will be required to undergo only a Release Medical Examination whereas those who are in low medical category will undergo a Release Medical Board.”

Ld. Counsel for the applicant submitted that the applicant was discharged from service in November 1987, therefore, this Army Order which has been issued in the year 1989 will not apply in this case.

We are not in agreement with the submission made by the Ld. Counsel for the applicant as the applicant is claiming for conduct of Release Medical Board for a SHAPE-1 officer in the year 2016. Therefore, Army Order 3/89 is applicable with full force. We do not find any substance in this Original Application. It is because if such prayer is admitted then the Army will have to conduct the Release Medical Board of each and every army person even if he is in medical category SHAPE-1. Such a practice would cause lot of undesirable burden on the army.

Accordingly, the **Original Application No. 136 of 2016** is **dismissed**.
