No. 198 of 2018</u></b></p> <p style="text-align: center;"><i>This is an application filed by the petitioner for execution of order dated 22.11.2017 passed in T.A. No. 692 of 2010. On the last date following order was passed :- "On behalf of the respondents, it is submitted by Wg Cdr RA Menon, Departmental Representative that as per the order under execution, the Tribunal had directed to ensure payment of interest to the wife of the petitioner, while her name is not mentioned in the PPO, therefore, the Department is facing problem in paying the interest to the wife of the petitioner. He submits that a direction be given to the respondents to deposit the amount of interest in the Registry, so that the same may be paid as per orders of the Tribunal. We accordingly direct the respondents to deposit the amount of interest in the Registry, AFT, RB, Lucknow within two weeks from today, which will be paid to Smt. We, therefore, direct the respondents to ensure payment of interest positively by the date fixed in the Registry, failing which they will have to pay cost of Rs. 25,000/-. List this case on 18.02.2019 for orders."</i></p> <p style="text-align: center;">Today it is submitted on behalf of the respondents that in pursuance of the order under execution, Bank Draft of Rs.28,000/- has been deposited in the Registry.
