The Applicant shall be entitled to service element of disability pension from the date of the disability pension has been paid with arrears of difference of payment within four months from the date of production of a certified copy of this order.</i></p> <p style="text-align: center;"><i>20. It is further held that the applicant is entitled to disability at the rate of 20% which on being rounded off would come to 50%. The applicant shall be paid the disability pension at the rate of 50% from the date of discharge. The same shall be paid within four months from the date of production of a certified copy of this order.”</i></p> <p>Ld. Counsel for the applicant submitted that the applicant was getting disability element and vide order under review only service element</p>

was granted and rounding off of same was also granted from the date of discharge i.e. 06.07.1987, while the Ld. Counsel for the respondents submitted that the Policy of rounding off came into existence with effect from 01.01.1996, hence, there is an error apparent on the face of record, needs to be corrected.

In view of above, **Review Application No. 04 of 2019** is **allowed**. The original order dated 16.01.2018 is **corrected** accordingly.
