However, we noticed that this print out was an inadequate evidence of despatch because it neither had date of despatch nor the address of despatch.</p> <p>Learned counsel for the applicant has stated that applicant has not received any payment till date. Therefore, we hereby direct the respondents to produce credible evidence as to what was the date of issue of ePPO and on what date and to which address it was despatched.</p> <p>A representative from PCDA (P) Allahabad informed that ePPOs are sent to record offices and further despatch to applicant is the responsibility of record office.
