Counsel for the respondents.</p> <p>This Original Application (Appeal) has been filed by the appellant for quashing the order dated 07.11.2018 passed by the respondent (General Officer Commanding In Chief, Southern Command) on the petition dated 20.08.2016 moved by the appellant wherein he has prayed to set aside the punishment awarded by SCM and reinstatement in service with all consequential benefits.</p> <p>The appellant was enrolled in the Army on 27.11.1990 and was dismissed from service by the SCM on 05.09.1995.</p> <p>This original application has been filed by the appellant after a delay of more than 3 months from the date of order of rejection of the petition, moved by the appellant. Since the petitioner has slept over his right for more than 20 years from the date of dismissal and no plausible explanation has been carved out by the appellant in his application for condonation of delay for the huge delay; no relief can be granted to the appellant .</p> <p>On behalf of the respondents facts are admitted. However, it is pleaded that the entire record of the applicant has been weeded out after expiry of period of retention.
