Counsel for the applicants – Union of India & Others.</p> <p style="text-align: center;">This application has been filed under Section 31 of the Armed Forces Tribunal Act, 2007 against the judgment and order dated 20.07.2021 of this Tribunal in Original Application No. 30 of 2021.</p> <p style="text-align: center;">There is a delay of 246 days in filing of leave to application.</p> <p style="text-align: center;">Submission of Ld. Counsel for the applicants – Union of India & Others is that delay in filing leave to appeal is not deliberate. His further submission is that after the Judgment applicants sent the order to the Deputy JAG (LIT) Headquarters, Central Command, thereafter it was sent to Officer-in-Charge Records, Army Medical Corps Records, Lucknow, PCDA and Chief of the Army Staff, New Delhi. After receiving the Legal opinion from the CGSC authorities have given instruction to obtain certificate of Leave to Appeal. Thus, his submission is that delay is not deliberate, but for the reasons stated above.</p> <p style="text-align: center;">Having heard the submission of Ld. Counsel for the applicants – Union of India & others and considering the facts and circumstances of the case, we find that explanation offered by the applicants for delay in filing Leave to Appeal is not sufficient. It is settled in law that if time limit is given for filing of any application and the same is not filed within that time limit, delay should be explained on day to day basis which applicant has utterly failed in the present</p>

case.

In the result, we find that delay is not condonable.

Accordingly, delay condonation application is **dismissed**.

Leave to Appeal being time barred is also **dismissed**.
