Brief facts of the case are that applicant was enrolled in the Territorial Army on 11.03.1988 and was discharged from service on 31.03.2008 (AN) under Territorial Army Rule 14 (a) of Territorial Army Regulation 1948 on completion of terms of engagement of service having rendered 13 years and 21 days of embodied service. The applicant was downgraded to low medical category P3 (T-24) for his disability <b>“INDIRECT INGUINAL HERNIA (RT) OPTD”</b> w.e.f. 13.11.2007. Prior to his discharge from service, applicant was</p>

required to undergo RMB but applicant did not appear before RMB. Though, the applicant was directed to report to MH Fatehgarh for RMB on 19.03.2008, however, applicant failed to carry out his RMB and proceeded on retirement without holding RMB.

4. Learned counsel for the applicant submitted that applicant was diagnosed suffering from disease "INDIRECT INGUINAL HERNIA (RT) OPTD" w.e.f. 07.08.2007 and was downgraded to low medical category P3(T-24). In Jan. 2008, his RMB was organised at MH Fatehgarh and his disability was assessed @ 20% for life as NANA but the applicant has not been granted disability pension. Though, the applicant served for 20 years and 21 days in TA but since embodied service was 13 years 21 days only, he has not been granted any type of pension. He placed reliance on the judgment of the Hon'ble Apex Court in **Dharamvir Singh vs. Union of India & Others**, 2013 AIR SCW 4236 and **Sukhvinder Singh vs. Union of India & Others** (2014) STPL (Web) 468 SC and pleaded to grant disability pension to the applicant duly rounded off to 50% for life.

5. On the other hand, learned counsel for the respondents submitted that applicant was enrolled in the Territorial Army on 11.03.1988 and was discharged from service on 31.03.2008 (AN) under Territorial Army Rule 14 (a) of Territorial Army Regulation 1948 on completion of terms of engagement of service having rendered 13 years and 21 days of embodied service. During service, applicant was downgraded to low medical category P3 (T-24) for his disability "**INDIRECT INGUINAL HERNIA (RT) OPTD**" w.e.f. 13.11.2007. As per Regulations 132 of Pension Regulations for the Army, 161 (Part-1) and Regulations 47 of Pension Regulations for the Army, 2008 (Part-1), minimum qualifying service for grant of service pension is 15 years, hence the applicant was not considered entitled for service pension.

6. Learned counsel for the respondents further submitted that prior to his discharge from service, applicant was required to undergo RMB in terms of Army Order 3/89, however, the applicant did not appear before RMB. His pension documents were received incomplete from his unit 114 Inf Bn (TA) JAT, hence, the same were returned to his parent unit by JAT Records vide letter dated 17.01.2009 for its completion and did not received back duly completed for holding of RMB. A reply dated 02.02.2009 received from unit stating that applicant has been discharged from service on 31.03.2008 on

completion of terms and engagement of his service. Though, the applicant was directed to report to MH Fatehgarh for RMB on 19.03.2008, however, applicant did not appear before the medical board and failed to carry out his RMB and thus, RMB could not be carried out.

7. We have perused the records and we find that applicant has been discharged from service without holding a Release Medical Board. Though, applicant was directed to report to MH Fatehgarh for RMB on 19.03.2008, however, he did not appear before the medical board and thus, RMB could not be carried out due to non appearance of applicant before the Medical Board. In view of above, a Re-survey Medical Board (RSMB) is required to be conducted for the applicant to assess gravity of his disease and medical category from which he was suffering at the time of retirement from service.

8. In view of aforesaid, the respondents are directed to conduct a Re-Survey Medical Board for the applicant to assess his medical condition recommending the percentage of disability, if any. The respondents are directed to inform applicant the place and date where RSMB is to be conducted and give effect to this order positively within a period of four months from the date of receipt of certified copy of the order.
