Counsel for the applicants – Union of India &amp; Others is that delay in filing leave to appeal is not deliberate. His further submission is that after receiving the copy of order the Tribunal remained closed due to COVID-19 Pandemic, hence, the applicant were unable to process the matter to the higher authorities having legal opinion of the Central Government Counsel and after receipt of legal opinion this application for leave to appeal has been filed. Thus, his submission is that delay is not deliberate,</p>

but for the reasons stated above.

Having heard the submission of Ld. Counsel for the applicants – Union of India & others and considering the facts and circumstances of the case, we find that explanation offered by the applicants for delay in filing Leave to Appeal is not sufficient. It is settled in law that if time limit is given for filing of any application and the same is not filed within that time limit, delay should be explained on day to day basis which applicant has utterly failed in the present case.

In the result, we find that delay is not condonable.

Accordingly, delay condonation application is **dismissed**.

Leave to Appeal being time barred is also **dismissed**.
