Counsel for the applicant is that when applicant was discharged from service he was posted within the territorial jurisdiction of this Tribunal, therefore, this Tribunal has jurisdiction to entertain the Original Application. The jurisdiction of the Tribunal cannot be denied on the ground that the applicant is resident of Madhya Pradesh.</p> <p>Upon hearing submissions of Ld. Counsel of both sides and considering that when discharged from service applicant was posted at Fatehgarh, a place, within the territorial jurisdiction of this Tribunal.
