His case was duly sanctioned by the Commanding Officer and was forwarded to the competent authority.3. Ld. Counsel for the applicant further filed a letter dated 06.09.2023 wherein the case of the applicant for discharge on compassionate grounds was turned down by the Board of Officers (BOO) for PMR quota 2023 held from 03 July 2023 to 07 July 2023 at Dte Gen of EME (Pers) and applicant was advised to forward fresh application for discharge on compassionate ground as and when applications are called for.4. Applicant's counsel emphasized that as per IHQ MoD (Army) DG EME (Pers) letter dated 29.09.2008, application of individuals for compassionate discharge who stand posted to North/ Easter Command Field/ HAA/ CI (Ops)/ RR Bn or are overdue to be turned over to these units/ area be rejected and applications of such individuals may not be forward to EME Records for pre-mature discharge. He urged that the applicant is now about to complete his peace tenure in present location and is due for posting to Field. Applicant will be adversely affected as the applications of the persons posted/ stand posted to field areas may not be considered for pre-mature discharge.

5. Ld. Counsel for the applicant submits that the applicant would be satisfied if a direction be issued to the respondents to consider his earlier application for PMR when applications are called for in future keeping in view that it is a case in continuation rather than a fresh case and waive off the restrictions imposed by EME Records.
6. Ld. Counsel for the respondents submits that the case of the applicant for compassionate discharge has been considered by the Board of Officers twice but could not be approved due to non availability of vacancy and policy constraints. Applicant has been advised to forward fresh application for PMR as and when applications are called for.
7. In view of the above, applicant is directed to forward a fresh application for PMR as and when the applications are called for and the respondents shall consider his application sympathetically keeping in view that his applications have been earlier rejected twice.
8. With the above directions, the instant original application stand disposed off.
