On the Case being taken up for hearing Mrs. Deepti P Bajpai, Ld. Counsel for the applicant – Union of India and Others is present.</li><li>2. This application has been filed under Section 31 of the Armed Forces Tribunal Act, 2007 against the judgment and order dated 14.07.2022 of this Tribunal in Original Application No. 841 of 2021.</li><li>3. It is submitted by the Ld. Counsel for the applicants – Union of India &amp; others that applicants want to file Appeal against the decision of this Tribunal, leave be granted for the same and delay of 09 months 16 days in filing of application be condoned.</li><li>4. In view of the facts stated in affidavit filed in support of delay condonation application, we find that cause shown is sufficient. Accordingly, delay is <b>condoned</b>. Delay condonation application stands disposed off accordingly.</li><li>5. Upon hearing submission of Ld.
