Counsel for the respondents.</p> <p style="text-align: center;">The applicant has filed this Review Application under Rule 18 of the Armed Forces Tribunal (Procedure) Rules, 2008 with prayer to review this Tribunal order dated 10.10.2022 passed in T.A. No. 25 of 2022.</p> <p style="text-align: center;">We have gone through the grounds and reasons indicated in the review application and have also gone through the judgment and order sought to be reviewed. The judgment and order sought to be reviewed was passed in proper prospective after considering all the facts and circumstances and also in view of the several pronouncement of the Hon'ble Apex Court. No illegality or irregularity or error apparent on the face of record has been shown to us so as to review the aforesaid judgment of this Court. The applicant has been granted disability element duly rounded off to 50% for life from the date of discharge from service as per rules.</p> <p style="text-align: center;">That apart, it is a settled proposition of law that the scope of the review is limited and until it is shown that there is error apparent on the face of record in the order sought to be reviewed, the same cannot be reviewed vide Order 47, Rule 1 sub-rule (1) of the Code of Civil Procedure. Review is not an appeal in disguise. It is nowhere within the scope of review to recall any order passed earlier and to decide the case afresh.</p>

In the light of the legal position crystalized by the Hon'ble Supreme Court in Para 9 of its judgment in the case of ***Parsion Devi and others vs. Sumitri Devi and others***, reported in (1997) 8 Supreme Court Cases 715 and in the case of ***S. Madhusudhan Reddy Versus V. Narayana Reddy and Others***, Civil Appeal Nos. 5503-04 of 2022, decided on 18.08.2022, we are of the considered view that there is no illegality or irregularity or error apparent on the face of record being found in the impugned order dated 11.10.2022, passed in T.A No. 25 of 2022, which may be corrected in exercise of review jurisdiction.

Accordingly, Review Application No. 92 of 2022 is hereby **rejected**.

M.A. No. 1228 of 2022, i.e.Application for hearing of the Review Application in the Court also stands disposed off.
