This is an application for condonation of delay in filing application for grant of leave to appeal in O.A. No. 202 of 2022. Admittedly, the application is time barred and has been moved after elapse of one year which is beyond statutory period. The Tribunal lacks jurisdiction to condone the delay under the Armed Forces Tribunal Act, 2007. It is well settled proposition of law that the Tribunal is not empowered to condone delay in moving application for leave to appeal. Accordingly, application for condonation of delay in moving application for grant of leave to appeal is not maintainable and is rejected.

Learned counsel for the respondents has removed the defects.
