This application has been filed under Section 31 of the Armed Forces Tribunal Act, 2007 against the judgment and order dated 23.03.2022 of this Tribunal in Original Application No. 648 of 2021.

There is a delay of 278 days in filing of leave to application.

Submission of Ld. Counsel for the applicants – Union of India & Others is that delay in filing leave to appeal is not deliberate. His further submission is that applicants being the Government functionaries and due to involvement of various agencies of the Government and perhaps lack of time management the delay has occurred. After sending the paper before the authorities, the authorities after going through the order passed by the Tribunal thought of filing leave to appeal application. Thus, his submission is that delay is not deliberate, but for the reasons stated above.

Having heard the submission of Ld. Counsel for the applicants – Union of India & others and considering the facts and circumstances of the case, we find that explanation offered by the applicants for delay in filing Leave to Appeal is not sufficient. It is settled in law that if time limit is given for filing of any application and the same is not filed within that time limit, delay should be explained on day to day basis which applicant has utterly failed in the present case. We further find that no point of law of general public importance is involved so that leave may be granted.

In the result, we find that delay is not condonable.

Accordingly, delay condonation application is dismissed.

Leave to Appeal is also **dismissed** on the ground of limitation as well as on merit also.
