His name be shown as Counsel for the respondents when the case is listed next.</p> <p>Heard Shri R. Chandra, Ld. Counsel for the applicant and Dr. Shailendra Sharma Atal, Ld. Counsel for the respondents.</p> <p>This application has been filed for condoning the delay of 04 months and 02 days in filing of Original Application for the grant of disability pension.</p> <p>It is submitted by the Ld. Counsel for the applicant that applicant was discharged in low medical category but no Release Medical Board was held, as, according to respondents, applicant had refused to undergo Medical Board proceedings. Applicant had filed an Original Application No. 235 of 2019 for holding Release Medical Board which was allowed vide order dated 15.01.2021 and respondents were directed to carry out the Release Medical Board. In the said Release Medical Board applicant's disability was not assessed, with the result applicant filed another Original Application No. 663 of 2021 which was also allowed vide order dated 18.02.2022 directing the respondents to assess the disability. Consequently, Release Medical Board was held wherein applicant was found suffering with 20% disability but the Board assessed it 'Nil' against which this Original Application has been filed.</p> <p>It is submitted by the Ld. Counsel for the applicant that applicant has suffered disability due to stress and strain of the military service, therefore, he is entitled to disability pension.</p> <p>Ld. Counsel for the respondents has vehemently opposed the prayer on the premise that applicant's disability is '<b>CNS (INV) VERTIGINOUS EPILEPSY</b>' which has no connection with the services rendered by him.</p> <p>Case needs adjudication, therefore, delay in filing the Original Application is <b>condoned</b>. Delay condonation application stands disposed off</p>

accordingly.
