Counsel for the applicant and Dr. Shailendra Sharma Atal, Ld. Counsel for the respondents.</p> <p><u>M.A. No. 1295 of 2022</u></p> <p>This application has been filed condoning delay of 48 years, 09 months and 21 days in filing Original Application for the grant of disability element of pension.</p> <p>It is submitted by the Ld. Counsel for the applicant that applicant was enrolled in the EME Corps of Indian Army on 23.05.1953 and was discharged from service in Low Medical Category on 08.09.1971. His disability assessed @70% for two years as attributable to military service by the Invaliding Medical Board for which applicant was in receipt of disability pension. The disability being for a period of two years only applicant was subjected to Re-Survey Medical Board (RSMB) in the year 1973 wherein disability was reduced to @50%. Accordingly, disability element of pension was granted which continued upto the year 1997. In the year 1997 applicant was again subjected to RSMB wherein his disability was assessed @50%, however, the PCDA (P), Allahabad reduced it to 20% and disability element of pension was granted accordingly. In the year 2000 RSMB of the applicant was again held wherein his disability was assessed below 20%, with the result disability element was stopped.</p> <p>Ld. Counsel for the applicant submitted that since the applicant's disability remained static for the above period, he is entitled to disability element of pension @70% to be rounded off to 75% from the date of discharge.</p> <p>As regards delay, Ld. Counsel for the applicant submitted that it is not</p>

deliberate. Further, limitation is not applicable in pensionary matter.

Ld. Counsel for the respondents has vehemently opposed the prayer on the premise that there is delay of more than 48 years and the same has not been properly and satisfactorily explained, hence, delay should not be condoned.

Upon hearing submissions of Ld. Counsel of both sides and considering that applicant was in receipt of disability element of pension till the year 2000 and thereafter his disability element of pension was stopped due to disability being assessed below 20%, disability claim cannot be denied on the ground of delay, we find that delay in filing the Original Application is contonable.

Accordingly, delay is condoned. Delay condonation application stands disposed off accordingly.
