After rejection of pre-confirmation petition, the appellantsubmitted post confirmation petition under Section 164 (2) of the Army Act 1950 vide letter No CAK/D/SP/AAFN/P164/19750 dated 20.02.2023 which is pending with the respondents. Appellant filed Original Application (Appeal) in this Tribunal with the prayer to quash the dismissal order passed by the GCM. In the meantime, he has filed an application for grant of bail. Learned counsel for the respondents opposed for grant of bail to the appellant on the ground that post confirmation petition filed by the appellant is pending with the respondents, hence respondents be directed to decide post confirmation petition as soon as possible.</p> <p>Ld.
