The applicant</p>

further submits that he is entitled to the earlier pension which he was getting on 30.06.2014

Objection has been made by Ld. Counsel for the respondents that it being a policy matter the applicant is being paid pension under the OROP scheme. We fail to understand that in case the applicant wants to retain his original pension which was paid to him from the date of superannuation, it is not open to the respondents to reduce the same in violation of principles of natural justice.

Accordingly we re-iterate our earlier order dated 13.09.2017 and direct the respondents to restore the pensionary benefits to the applicant which he was getting prior to 01.07.2014.

We clarify our earlier order to the extent that entitlement of pension paid to the applicant on completing 33 years of service including six years of weightage shall not be reduced for any reason whatsoever and the pension shall be restored as applicable for 33 years of service.

List the case on **27.10.2017** for hearing and to enable Ld. Counsel for the respondents to submit the compliance report.

It is made clear that in case the order is not complied with, Head of the Department dealing with pension matters shall appear in person before this Tribunal on the date fixed to assist the Tribunal.
