Apparently the Central Govt Standing Counsel are doing Begar in this Tribunal which is prohibited by Article 23 of the Constitution of India. The Govt of India seems to be taken Begar from the lawyers and no payment of fees and expenses has been made since for the last two years as stated by Shri Namit Sharma, Advocate.

Though it is not within our jurisdiction to issue order for payment of fees and expenses but since the Central Govt Standing Counsel are officers of the Court, we re-iterate the earlier order dated 12.05.2017 and expect from the authorities concerned to ensure payment of fees and expenses or resolve the dispute expeditiously so that the Tribunal may receive proper assistance from lawyers representing Union of India and Armed Forces. In case controversy is not settled we may be constrained to look into the matter as to how the controversy may be relegated to the High Court to exercise extraordinary jurisdiction for payment of fees and expenses to the lawyers engaged for defending the Union of India and the Armed Forces to pursue the case in the Armed Forces Tribunal, Regional Bench, Lucknow.

We leave it open to the Central Govt Standing Counsel to approach the Hon'ble High Court or the Hon'ble Supreme Court to ventilate their grievance since the functioning of the Tribunal is hampering because of non payment of fees and expenses to the lawyers representing the respondents, there shall be no option in future except to take steps in accordance with law.

The Registrar of the Tribunal shall send copy of the present order to Hon'ble Prime Minister to apprise the situation under which the lawyers of Govt of India are working without payment of fees and expenses and in spite of order dated 12.05.2017 no decision has been taken.

Copy of this order be also sent to the Secretary, Ministry of Law and Justice, Secretary Defence Ministry, Chief of Army Staff, Chief of the Air Staff and Chief of the Naval Staff by the Registry within three days from today.

Since Ld. Counsel for the respondents is not prepared with the

case and could not get typed certain material which he wanted to produce, we defer the proceeding.

List the case on **11.10.2017** for further hearing.

Certified copy of this order shall be provided to Ld. Counsel for the parties free of cost within three days from today. It shall be open to the respondents counsel to submit representation along with copy of the earlier order dated 12.05.2017 and present order to the Hon'ble Prime Minister and other dignitaries referred to in the present order to ventilate their grievance.
