Ld. counsel for the respondents further submitted that the applicant has preferred first appeal to the respondents on 08.11.2023 and without waiting for decision on his representation, he filed the instant O.A before this Tribunal on 01.12.2023 i.e. before the expiry to six months of his representation. As such, the O.A is pre-mature and is not maintainable.</li><li>4. Ld. counsel for the applicant filed the reply to the objection raised by the respondents, which is taken on record.</li><li>5. Applicant's counsel submits that this Tribunal has inherent power to entertain the O.A even when the provisions of the Act has not been complied strictly. In support of his averments, Id. counsel for the applicant relied upon the judgement and order passed by this Tribunal in the cases of Lt. Col. Arun Kant Singh (Retd.) Vs. Uol &amp; Ors decided on 09.01.2023 and Maj. Neha Akhoon Vs Uol &amp; Ors decided on 27.04.2023 wherein no first appeal was preferred by the applicant. He also placed reliance on the case of Maj. Uma Shankar (Retd) Vs Uol &amp; Ors decided on 21.02.2023 wherein after preferring the first appeal and without waiting for the statutory period to get over, the case was admitted.</li><li>6. Perusal of the file reveals that the original application has been filed for grant of disability pension to the applicant. The applicant has preferred</li></ol>

his first appeal on 08.11.2023 which has been decided by the respondents vide letter dated 20.02.2024. Before taking the decision on the applicant's representation by the respondents, the applicant has filed this O.A before this Tribunal on 01.12.2023 i.e before the stipulated period mentioned in the AFT, Act.

7. We are of the view that the no fruitful purpose would be served, if this original application is rejected at this stage on technical ground being pre-mature, as, now the claim of the applicant has been rejected by the respondents vide letter and order dated 20.02.2024.
