Counsel for the applicant submits that the delay in filing of the application is not deliberate but of the reasons stated in affidavit filed in support of delay condonation application. He submitted that RMB papers and the letter of rejection of disability pension dated 02.12.2010 were not available to him and he obtained the same through RTI which he received in October 2023 itself. He further submitted that after retirement, the applicant was involved in some domestic problems and due to ailment of his parents and wife, applicant could not approach the Tribunal.5. Applicant's counsel also urged that the instant case has been filed for grant of disability pension for which law of limitation does not apply. He relied upon the judgement passed by the Hon'ble Supreme Court in the case of UoI Vs Tarsem Singh & Another (MANU/SC/7676/2008).6. Ld. Counsel for the respondents vehemently opposed the submissions of the Ld. Counsel for the applicant and submitted that the delay has not been properly and satisfactorily explained on day-to-day basis. The applicant has not provided any reasonable ground for explaining the reasons for delay in approaching this Tribunal. He placed reliance on the judgements passed by the Hon'ble Supreme Court in the following cases:

- (i) N. Balakrishnan Vs. M. Krishnamurthy (1998) 7 SCC 123.
- (ii) C. Jacob Vs. Director of Geology and Mining and Another reported in (2008) 10 SCC 115.
- (iii) Union of India & Ors. Vs. Rajwanti.
- (iv) Basawaraj and Another Vs. Special Land Acquisition Officer.

7. We have considered the submissions of Ld. Counsel for the parties and we find that the cause shown for the delay is sufficient. Further being pensionary matter and in view of the law laid down by the Hon'ble Apex Court in the case of **Union of India and Others Vs. Tarsem Singh (2008 (8) SCC 646)**, delay is condoned. Delay condonation application stands disposed of.
