Ld. Counsel for the respondents has raised objection regarding delay in filing Original Application as well as Territorial Jurisdiction of this Tribunal. It is submitted by the Ld. Counsel for the respondents that delay in filing of Original</p>

Application has not been explained on day to day basis. He further submitted that the applicant is resident of Bengaluru, Karnataka as such this Tribunal has no territorial jurisdiction to entertain the Original Application.

13. In reply, Ld. Counsel for the applicant submitted that the delay in filing Original Application is neither intentional nor deliberate but for the reasons stated in affidavit filed in support of delay condonation application. He further submitted that the applicant has mentioned the address of Lucknow as such this Tribunal has territorial jurisdiction to entertain the Original Application.

14. Upon hearing submissions of Ld. Counsel of both parties with regard to territorial jurisdiction of this Tribunal we find that the applicant is resident of Bengaluru and has mentioned local address at Lucknow also. In this case the impugned order dated 02.11.2022 has been issued by the Army Medical Corps Record Office (respondent No. 3) which is situated at Lucknow, therefore, in view of Rule 6 (1) (ii) of Armed Forces Tribunal (Procedure) Rules, 2008 this Tribunal has territorial jurisdiction to entertain the Original Application. As such the Original Application is maintainable.

15. For the reasons stated in affidavit filed in support of delay condonation application, delay is **condoned**. Delay condonation application stands disposed off.

It is submitted by the Ld.
