As a result of foregoing discussion, the Petition is allowed and impugned order of discharge dated 16.04.2022 is set aside. The petitioner would be reinstated in service notionally and shall be retired on due date with all consequential benefits like gratuity, full pension etc. However, he would not be entitled to back-wages. In the facts and circumstances, it is directed that the petitioner would be entitled to payment of cost which we quantify at Rs 50,000/-. The cost shall be paid in full within four months from the date of production of a certified copy of this order. All consequential benefits including arrears of pension with interest thereon at the normal rate shall be paid to the petition within four months from the date of production of a certified copy</i></p>

of this order.”

7. Ld. Counsel for the applicant has filed affidavit in support of the objection against compliance affidavit in which date of payment made to the applicant is mentioned.

8. Respondents were granted time to file reply, if any, to the objection against compliance report but reply has not been filed.

9. Ld. Counsel for the respondents prays for and is granted two weeks further time to file reply, if any, on payment of additional cost of Rs.5,000/- which shall be remitted to the applicant.

10. It is made clear that if reply along with calculation sheet is not being filed it may be deemed that respondents have nothing to say against non-payment of interest as directed in the order dated 07.04.2017.
