The claim of the applicant for disability pension has been rejected by the respondents to which the applicant has preferred First Appeal on 02.09.2023 which is still pending after lapse of more than six months.7. Applicant's counsel further submitted that the instant O.A. may be disposed of by directing the respondent to take decision on the representation/appeal preferred by the applicant and ends of justice would be served if a direction is given by this Tribunal to the respondents/competent authority to consider and dispose of the pending first appeal dated 02.09.2023 (Annexure A-1) to this O.A. which may be decided by the Respondent Nos. 2 and 3, by way of reasoned and

speaking order within a stipulated period of time.

8. Learned counsel for the respondents has no objection to this and agrees with the submission of the applicant's counsel.
9. In view of the relief sought and innocuous prayer made by the applicant, respondents/competent authority is directed to consider and decide the pending appeal dated 02.09.2023 of the applicant (Annexure A-1) and pass a reasoned and speaking order according to law within a period of three months from the date of receipt of certified copy of this order, under intimation forthwith to the applicant.
10. It is made clear that nothing has been commented upon the merits of the case.
11. Applicant shall be at liberty to approach proper forum if he is not satisfied with the decision of the respondents passed on his representation.
12. The OA is disposed of accordingly.
