Counsel for the applicant submits that the delay in filing of this application is not deliberate but for the reasons stated in affidavit filed in support of delay condonation application. Further submitted that the applicant had no medical document in his possession and he had not provided the copy of Resurvey Medical Board which he has received through RTI in February 2024 itself. He further submitted that the O.A has been filed for disability pension which is recurring cause of action and bar of limitation does not apply in this case.</li><li>5. Ld.
