- 9. Accordingly, respondents are directed to pay the interest @8% p.a. on the arrears from 01.08.2017 to 12.10.2023 to the applicant within a period of two months from today.
- 10. With the above directions, Original Application is disposed of finally.
- 11. Misc. Application(s), if any, pending for disposal, shall be treated to have been disposed of.
