Application No.447 of 2014) was moved, but the same was rejected vide order dated 22.04.2014, as it was not pressed by the learned counsel for the applicant and he was granted three weeks' further time to move fresh amendment application. Thereafter, on the request of the learned counsel for the applicant, time was granted</p>

again and again and ultimately, 29.10.2014 was fixed. In the meantime, an application for amendment (Misc. Application No.1179 of 2014) was moved by the applicant, but it was also not pressed by the learned counsel for the applicant and as such, it was rejected vide order dated 29.10.2014 and 03 weeks' further time was granted for moving fresh amendment application, but the same has not been moved, as yet, without any sufficient or valid reason.

The case history, as mentioned above, indicates that no progress has been made in the instant case for the last about more than one year due to inaction on the part of the applicant. It appears that the applicant is not interested in proceeding with the case.

The request made on behalf of the applicant for granting further time for moving appropriate amendment application, being unreasonable, is hereby rejected.

The Misc. Application No.1035 of 2013, Amit Kumar Kohli vs. Union of India and others, is hereby rejected for want of prosecution.

The Original Application No. Nil of 2013, Amit Kumar Kohli vs. Union of India and others, being time barred, is also dismissed.
