04.07.2014 and ten days' time was granted for filing amendment application and 17.07.2014 was fixed; that the counsel for the applicant wrongly noted the next date of listing as 27.07.2014 in place of 17.07.2014 and when the case was listed on 17.07.2014, the applicant's counsel could not appear and hence, the case was dismissed in default for want of prosecution vide order dated 17.07.2014; that the applicant has filed the Restoration Application well within time after receiving the copy of the order dated 17.07.2014.

Learned counsel for the respondents has opposed the Restoration Application, on the ground that the Transferred Application was not dismissed in default of the counsel for the applicant, but due to non-compliance of the order dated 15.04.2014 and for want of prosecution. He has further submitted that no sufficient ground has been shown for recalling the order dated 17.07.2014 and for restoration of the instant Transferred Application.

The applicant has moved the Restoration Application for recalling the order dated 17.07.2014. The said order may be reproduced as under, for ready reference:-

“List revised.

None appears on behalf of the applicant.

Present : Shri D.K. Pandey, Counsel for the respondents.

On the request of learned counsel for the applicant, three weeks time was granted to move appropriate amendment application challenging the Summary Court Martial proceedings and seeking consequential amendments, vide order dated 15.04.2014, but, no

amendment application was moved. Thereafter, three weeks further time was granted for the same purpose, vide order dated 12.05.2014. The applicant was again granted ten days further time to move appropriate amendment application, vide order dated 04.07.2014, but, the amendment application has not been moved, as yet and on account of it, the proceedings are held up.

The Transferred Application No. 17 of 2013 Sadashiv Maurya Versus Union of India and Others, is dismissed for non-compliance of the Tribunal's said orders and want of prosecution."

From the bare perusal of order dated 17.07.2014, it is clear that more than sufficient time was granted to the applicant to move appropriate amendment application challenging the Summary Court Martial proceedings and seeking consequential amendments, but, it was not moved and on account it, further proceedings were held up. It is also clear from the said order that the instant Transferred Application was dismissed for non-compliance of the Tribunal's orders dated 15.04.2014, 12.05.2014 and 04.07.2014 and for want of prosecution and not due to absence of the applicant or his counsel on 17.07.2014, as contended by the learned counsel for the applicant. From the order sheets dated 15.04.2014, 12.05.2014 and 04.07.2014, it is clear that Shri O.P. Kushwaha, learned counsel for the applicant was present on those dates and the orders were passed in his presence and the time was granted again and again on his request.

The Restoration Application was placed before us for the first time on 20.08.2014 and in presence of the applicant's

counsel, 28.10.2014 was fixed. On his request, the case was adjourned, vide order dated 28.10.2014 and 27.11.2014 was fixed. On 27.11.2014, the case was adjourned on the request of the applicant's counsel and today's date was fixed. Admittedly, the appropriate amendment application has not been prepared, as yet, because the applicant, who resides at District Sultanpur, not far away from Lucknow, has not been able to come. It indicates inaction on the part of the applicant to proceed further with the case.

After considering the record and the submissions made on behalf of both the parties, we are of the view that there is no sufficient or valid ground to recall the order dated 17.07.2014. The Restoration Application (Misc. Application No.1024 of 2014, Sadashiv Maurya vs. Union of India and others), lacks merit and it is rejected, accordingly.
