Counsel for the respondents.</p> <p>The present Original Application has been filed under Section 14 of the Armed Forces Tribunal Act, 2007 for issuing direction to the respondents to decide applicant's Appeal dated 13.08.2019 regarding paying interest @18% per annum on the amount of Rs.75,210/- which had been wrongly deducted from the arrears of salary of the applicant's husband towards A.G.I.F. deduction.</p> <p>It is submitted by the Ld. Counsel for the applicant that respondents had wrongly deducted Rs.75,210/- from the arrears of salary of the applicant's husband towards A.G.I.F. deduction at the time of his discharge while he was physically not in service. It is further submitted that applicant's husband had filed Writ Petition in the Hon'ble High Court against his illegal discharge from service which after constitution of this Tribunal was transferred to this Tribunal and re-numbered as T.A. No. 1312 of 2010. It is further submitted that said T.A. was allowed by this Tribunal on 01.04.2011 and while setting aside applicant's husband discharge order dated 01.11.1999 the respondents were directed to treat the applicant's husband in service till normal terms of his engagement as Havildar and pay arrears of salary as well as all consequential benefits to him/his legal representative w.e.f. 01.11.1999 till the date his engagement was to continue or till the date of death, whichever was earlier. It is further submitted that in compliance to above, respondents credited an amount of Rs.75,210/- only in the applicant's account without paying any interest thereon, hence, this Original Application.</p>

In reply, Ld. Counsel for the respondents submitted that order dated 01.04.2011 passed in T.A. No. 1312 of 2010 being fully complied with and no objection being raised by the applicant regarding payment of interest on the amount of A.G.I.F. deduction Rs.75,210/- in Execution Application No. 45 of 2015, the same cannot be raised again by way of separate Original Application.

Upon hearing submissions of Ld. Counsel of both sides we find that in respect of cause of action accrued on account of illegal discharge applicant's husband had filed a Writ Petition in the Hon'ble High Court of Judicature at Allahabad which was transferred to this Tribunal and re-numbered as T.A. No. 1312 of 2010 after constitution of this Tribunal under Armed Forces Tribunal Act, 2007. We further find that this T.A. was allowed on 01.04.2011 by a detailed order passed by this Tribunal and while setting aside the discharge order of the applicant's husband the respondents were directed to treat applicant's husband in service till the normal terms of his engagement as Havildar and they were further directed to pay arrears of salary to him along with consequential benefits with effect from 01.11.1999 till the date his engagement continued. We further find that after the T.A. being allowed respondents complied with the order including payment of Rs.75,210/- which they had wrongly deducted towards A.G.I.F. deduction. The payment of A.G.I.F. deduction was made during the pendency of Execution Application and at the time of payment applicant had admitted that the order passed in T.A. was fully complied with.

Once the fact regarding compliance being admitted and Execution Application being dismissed on account of full and final satisfaction, the applicant cannot raise the issue of non payment of interest on the amount of A.G.I.F. deduction saying respondents were under obligation to pay interest also. The relief claimed in Original Application being barred under law for not being pressed earlier, the Original Application is liable to be dismissed.

Accordingly, Original Application is **dismissed** being not maintainable.

Counsel for the applicant is that applicant had preferred First Appeal against the order of denial of disability pension passed by the respondent No. 3. He further submits that said First Appeal was rejected on 02.05.2019 and decision of rejection was conveyed to the applicant on 05.06.2019 by the respondent No. 4 with suggestion to file Second Appeal which the applicant preferred on 23.11.2019, which the respondents did not dispose of till date. Thus, he submits that present Original Application has been filed after the expiry of six months from the date Second Appeal was filed which is well within time as per Section 22(1)(b) of the Armed Forces Tribunal Act, 2007.</p> <p>Regarding above, submission of Ld.
