Initially he was declared medically fit but later on he was declared to be suffering from colour blindness. In para 4.4 of the application it has been specifically pleaded that on 25.09.2016 instead of despatching the applicant for training to BEG Centre Roorkee, the applicant was referred for re-medical examination to ZRO Lucknow by Medical Officer of ARO Meerut. After returning from Lucknow on 27.09.2016, the ARO Meerut further referred the applicant to Military Hospital Meerut for confirmation if he was suffering from colour blindness but such disease was not found in the applicant. Ld. Counsel for the applicant has specifically pleaded that the applicant is medically fit and he is not suffering from colour blindness. Once Military Hospital Meerut declared him fit and he was not found to be suffering from colour blindness, then prima facie there is no justification on the part of respondents not to permit the applicant to join.</p> <p>Accordingly, we direct the Command Hospital, Central Command Lucknow to re-examine the applicant with regard to</p>

colour blindness or any other disease which the applicant may be suffering and forward the report of his medical status pertaining to medical fitness for enrolment in the Army to join for training through OIC Legal Cell.

The applicant shall appear before the appropriate authority of the Command Hospital, Central Command Lucknow with regard to medical examination.
