Since the foundation of the impugned order is personal grievance or grudge, the subsequent proceeding vitiates.</p> <p>It has been further argued by Ld. Counsel for the applicant that he was on sanctioned leave upto 29.09.2013 but before the expiry of leave he was brought to unit under escort on 23.09.2013.
