Counsel for the respondents submitted that in spite of best efforts made, the entire record could not be made available to him. On query made by the Court, he failed to give reply to the averments contained in affidavit dated 23.02.2017 wherein it has been averred that in pursuance to movement order, the petitioner moved to Battalik (J&K). However, in the supplementary affidavit dated 23.02.2012, in para-6, the petitioner has categorically stated that he was present in Battalik and in duty charge he has been shown as working from 23.11.1999 to 31.12.1999.</p> <p>Prima facie, it appears that no genuineness has been questioned by the respondents by filing response or otherwise.</p> <p>Shri Namit Sharma, on specific query made by the Tribunal, how the respondents have filed affidavit mentioning that an amount of Rs. 35,000/- was paid on various dates, we have been informed by the Ld. Counsel for the respondents that the petitioner had signed payment receipt at Headquarter, Rajputana Rifles Regiment (J&K). The question directly involved is that while the petitioner has established from the duty chart that he was posted at Battalik (J&K), on the other hand the respondents took the stand that the petitioner himself had signed in receipt of payment of outstanding dues at</p>

Rajputana Rifles Regiment (J&K). The stand taken by the respondents has been denied by Ld. Counsel for the petitioner and it was vehemently argued by him that since the petitioner was posted at Battalik, there was no occasion for him to go to the Headquarter where the Rajputana Rifles Regiment was located in J&K and signed the acquaintance roll in token of receipt of aforesaid amount, as has been submitted by Ld. Counsel for the respondents assisted by Maj Rajesh G.K.

It appears that the respondents have not made necessary home work while dealing with the present matter.

At this stage, Shri Namit Sharma, Ld. Counsel submits that he and a number of other advocates are appearing without payment of fees since several months and it is very difficult for them to spend from their own pocket to prepare the cases.

There appears to be no room of doubt that in case lawyers are not paid within a reasonable time their fees and expenses, they will not be able to discharge their professional duties with attachment as well as commitment. A number of lawyers have been engaged by Union of India having no other source of livelihood. How they will be able to manage their affairs and concentrate to prepare cases is not understandable. Though it is not for us to look into the matter, but lawyers attending the Tribunal representing Union of India are officers of the Court and we are concerned to the problem, if any, which comes in their way to discharge professional duties.

It shall be appropriate for Chief of the Army Staff as well as Ministry of Defence and Ministry of Law and Justice to look into the matter so that functioning of the Tribunal does not suffer setback in defending their cause because of the problem in question (payment of fees and expenses to their counsels). Some mechanism may be adopted to pay fees and expenses within a reasonable period keeping in view the terms and conditions of their appointment. Hence we direct the Registrar of the Tribunal to send a copy of the present order to the Secretary, Ministry of Law and Justice, Defence Secretary as well as the Chief of the Army Staff to look into the matter of lawyers who have been appointed to defend them in this Armed Forces Tribunal, Regional Bench, Lucknow.

Costs deposited by respondents shall be released in favour of Ld. Counsel for the petitioner by the Registry.

Respondents shall explain in terms of observations made hereinabove with regard to conflicting material on record.

List the case on **26.05.2017** for further hearing **as first case in the cause list.**
