- 11. Applicant has also sought Interim Relief against alleged illegal recovery from pension to which objection has been filed by the respondents.
- 12. Heard learned counsel for the parties on grant of interim relief and perused the record.
- 13. Learned counsel for the applicant submits that applicant was enrolled in the Army on 29.02.1996 and discharged from service on 28.02.2007. He was being paid disability element @ 50% regularly, however, from 01.06.2024, it has been suddenly stopped and recovery of Rs. 8738/- has been commenced w.e.f. 01.06.2024, which is illegal and therefore, recovery of amount from pension to be stayed in view of the judgment of the Hon'ble Apex Court dated 18.12.2014 in Civil Appeal No. 11527 of 2014, **State of Punjab &OrsvsRafigMasih(White Washer).**
- 14. Learned counsel for the respondents raised objection on grant of interim relief.
- 15. In view of the submissions made by learned counsel for the parties and fact of the case, we are of the view that there is sufficient ground to grant interim relief and to stay recovery being made from pension of the account. Accordingly, further recovery from pension of the applicant is stayed till next date of listing.
