Applicant has moved M.A. No. 936 of 2022 for condoning the delay in filing M.A. No 937 of 2022.</p> <p>Heard learned counsel for the applicant and perused the record.</p> <p>On 05.10.2020 M.A. No. 1513 of 2018 inre O.A. (Nil) of 2018 was dismissed in default of the applicant. It is submitted by learned counsel for the applicant that this matter was listed on 13.11.2018 and thereafter on 05.10.2020 and thereafter no date of hearing could be known to the applicant due to Covid-19 pandemic situation nor there was any date known about the instant case on official website. Since the applicant was having no knowledge about the further date in this case, the applicant visited the Bench at Lucknow physically to know date of this case, when it came to the knowledge of the applicant for the first time on 26.04.2022 after receiving certified copy of court order that the case has been dismissed on 05.10.2020.</p> <p>It is submitted that due to Covid-19 Pandemic and medical sickness applicant counsel was unable to move the application for recall of the order</p>

dated 05.10.2020 within the limitation period.

Learned counsel for the respondents submits that day to day delay in moving the application is not explained and reasons given in the application is not sufficient to recall the order.

In view of grounds stated in the application we are of the view that in the interest of justice an opportunity should be given to the applicant.

Accordingly, application is liable to be allowed on cost.

Application for restoration is allowed subject to payment of cost of Rs 1,000/-. The cost shall be deposited within one month. The cost so deposited shall be remitted to the account section Local Bar Association for utilisation for upgradation of the library.
