Counsel for the respondents submits that life certificate in respect of the applicant and some other documents are required to release the pension payment.</li><li>3. Ld. Counsel for the respondent No. 5 produce a letter dated 15.09.2021, relevant portion of which is reproduced as under: <p style="text-align: center;">“उपरोक्त संदर्भ में यह सज्ञान लिया जाता है कि उपरोक्त पे अनर मानसिक विकृति से संबंधित है अतः इस मामले में DPPI 2013 के पैरा 81.1 एवं 81.2 (II) के अनुसार माननीय मजिस्ट्रेट से किसी अन्य व्यक्ति के पक्ष में पे अन भुगतान प्राधिकार जारी करवाकर इस कार्यालय में प्रस्तुत करें।”</p></li><li>4. Perusal of the above letter reveals that PCDA (Pension) has written a letter to Treasury Officer, Khatima, Uttarakhand stating that in case of a person who is insane or lunatic, there is requirement of a certificate signed by a Magistrate in favour of other member (family member) for the purpose of pension payment.</li><li>5. Ld. Counsel for the applicant vehemently opposed the submission of the respondents' counsel and submitted that he has spoken to the applicant today itself on telephone and in no case person who is insane or lunatic can made any meaningful conversation and that the pension should be paid to the applicant himself.</li></ol>

6. On query, Mohd. Sheeraz, Sr. Treasury Officer, Khatima, Uttarakhand present before the Court clarified that the account in which money is to be transferred pertains to applicant himself.
7. In the above circumstances, we see no reason to file additional documents from the applicant's side. Considering the old age of the applicant, we hereby direct the respondents/ competent authority to release the service pension of the applicant in his account as per rules within a period of one month from the date of receipt of certified copy of this order.
8. With the above directions, O.A stands disposed of.
