Counsel for the applicant that during course of trial the applicant had submitted two applications for summoning of witnesses i.e. 27.06.2011 and 12.04.2012. It is also submitted that application dated 27.06.2011 was submitted in pursuance of letter issued on behalf of the Commandant dated 10.06.2011. It is specifically argued and pleaded in the O.A. that the Presiding Officer has not sent notices to the witnesses whose names are contained in application dated 27.06.2011. So far as subsequent application dated 12.04.2012 is concerned it is submitted that some of the witnesses summoned appeared and some declined to appear.</p> <p>Argument advanced by Ld. Counsel for the applicant is that it was the duty of the Presiding Officer of the General Court Martial to summon the witnesses mentioned by the applicant in pursuance to Section 135 of the Army Act.</p> <p>Ld. Counsel for the applicant further submitted that the applicant was not permitted to cross examine the witnesses and also he was not permitted to lead evidence in defence. Earlier order of this Tribunal passed in T.A. No. 68 of 2010 dated 05.10.2010 shows that the respondents had not permitted the</p>

applicant to cross examine the witnesses. In the present O.A. the applicant submits that copies of the statements of witnesses were not provided to him. He was permitted to examine the statements but was not permitted to take notes of the contents of the statements. It is submitted that for this reason also the applicant's counsel could not effectively cross examine the witnesses.

We had made specific query to Ld. Counsel for the respondents and OIC Legal Cell to apprise the Tribunal with regard to order passed by the Presiding Officer on these two applications which they have failed to do.

The respondents prima facie seem to have committed the same illegality on account of which the matter was earlier remanded by the Tribunal. It is a serious concern for us.

Let entire record of the General Court Martial including order sheets of proceedings be produced for perusal of the Tribunal on the next date of listing.

The Presiding Officer concerned of the General Court Martial shall appear on the date fixed to assist the Tribunal.

List the case on **16.11.2016** for further hearing.

From a perusal of the record, it would transpire that the Applicant after being charged for offences under section 46 (a) as well as 39 (d) of the Army Act was visited with the punishment of R.I. for 9 months in civil prison attended with punishment of dismissal from service which was challenged by filing petition under section 164 of the Army Act before the competent Authority. The said petition culminated in being rejected vide order dated 4<sup>th</sup> May 2016.

We have heard learned counsel for the Applicant as also learned counsel for the Respondents.

The argument advanced across the bar by learned counsel for the Applicant is that the punishment awarded to the Applicant, first of all, is not founded on appreciation of evidence adduced by the prosecution and thus, it is a case which is wanting in sufficient evidence and punishment awarded is not sustainable. To sum up, it is submitted that the punishment awarded to the Applicant is too harsh which could not have been awarded since the testimony of the victim Prasenjit Dhara cannot be taken upto mark as it was not adequately corroborated by Medical evidence.

In our considered view, the above submission seems to be loaded with substance.

Accordingly, the O.A is admitted.

M.A No 1857 of 2016 whereby objection has been filed is rejected as the O.A has been filed within time and there appears to be no delay. The office report is also reticent on the point.

Learned counsel for the Respondents prays for and is granted four weeks' time to file counter affidavit. Rejoinder affidavit, if any may be filed within two weeks next thereafter.
