Substantially direction was to decide the revision by a speaking order within three months. The revision remains yet to be decided. It would transpire that on 7.04.2016, we granted further time to decide the revision. That order also has not been observed in compliance. Now, further time has been sought to comply with the order. These acts of omission and commission seem to be not justified more so when the order was only to decide the revision. Keeping in view the slackness on the part of the respondents, we grant further time of course, subject to payment of cost which we quantify at Rs 25000/- which shall be deposited with the Registry of the Tribunal within a month. This is an application under Section 14 of the Armed Forces Tribunal Act, 2007 being aggrieved with the ACR entry of the period 01.07.2001 to 30.06.2012.

Preliminary objection has been raised by Ld. Counsel for the respondents assisted by OIC, Legal Cell that the O.A. is not maintainable for two reasons; firstly, relief has been claimed on different cause of actions. Applicant has impugned non empanelment for promotion to the rank of Maj Gen by order dated 15.07.2015. Submission is that the applicant has not impleaded all those persons as necessary parties who were empanelled vide order dated 15.07.2015 but prayer has been made for setting aside said order dated 15.07.2015.

However, Ld. Counsel for the applicant submitted that the O.A. is not bad because of non-joinder of parties for the reason that the applicant has not claimed any relief against persons empanelled for promotion, but has claimed setting aside the result.

It has not been disputed that the applicant has not been selected and empanelled by order dated 15.07.2015. Accordingly setting aside of the order shall mean to direct to induct the applicant in the panel of selected candidates for promotion to the post of Maj Gen. We feel that relief claimed by the applicant is misconceived. Setting aside the impugned order shall mean that all selections done shall go into wind and to follow up to initiate fresh decision making process subject to directions issued by the Tribunal.

It is well settled law that the persons who are affected shall be necessary parties in O.A. No 255 of 2012 **NK Mehta vs. Union of India & Others** decided by this Tribunal on 13.05.2016 . Needless to say that all persons who are empanelled in order dated 15.07.2015 are necessary parties. Of course in case the applicant would have prayed for his empanelment without making prayer for setting aside order dated 15.07.2015 he would may have a case but in the present case setting aside the order dated 15.07.2015 shall affect the whole selection process done. We have held in the case of **Brig NK Mehta vs Union of India & Others** (supra) that selection process involves assessment of comparative performance of all officers and not one. Accordingly there appear no reason to hold that setting aside of the impugned order shall not affect the other persons.

Secondly, it is incorrect to say that the applicant has not preferred

O.A. against multiple cause of action. Setting aside impugned order is different than setting aside ACR entry.

O.A. is **rejected** in limine at the admission stage itself with liberty to the applicant to prefer fresh O.A. in case advised to do so.
