Grievances of the applicant is that there were numerous financial irregularities while he was posted with Additional Directorate General of National Cadet Corps of U.P. Directorate and his performance during the period was not considered upto the mark by the officer concerned by lowering down his ACR entries acting malafidely with vindictiveness. Perusal of the impugned order dated 04.05.2016 shows that ground raised by the applicant has been precisely mentioned therein with regard to vindictiveness and harassment by IO and RO but no findings have been recorded therein.</p> <p>Issue notice to opposite parties No 5, 6 and 7. Thus it appears that the pleadings and grounds raised by the applicant has not been taken into account while passing</p>

speaking order rejecting the applicant's statutory complaint by impugned order dated 04.05.2015. Mere referring the ground raised by the applicant do not make out a case keeping in view the records and materials considered enough while rejecting the applicant's statutory complaint and reasons should have been given sufficiently.

This is a fit case for adjudication.

We have also been taken through the materials on record.</p> <p>The Petitioner had initially preferred a writ petition being aggrieved by the action of his not being promoted on the post of Subedar from the rank of Naib Subedar. In the course of time, the aforesaid T.A stood transferred to this Tribunal and was registered as T.A No 1380 of 2010.</p> <p>The solitary argument advanced across the bar is that the Petitioner was not promoted to the post of Subedar inspite of the fact that he was eligible for promotion within the category of Yadav Community in order of seniority attended with submission that in Sept 1999, approval was sent to consider and promote the Petitioner to the post of Subedar with effect from 1st Nov 1999 but the authority that be, sat tight over the matter and as a consequence, the Applicant stood retired. <b>Per contra</b>, the argument is that the policy for</p>

promotion within the Community had undergone change subsequently vide circular dated 24.05.1999 and by this reckoning, the Petitioner was found not entitled for being promoted in terms of policy in vogue prior to issue of circular aforesaid. Be that as it may, the fact remains that inspite of the fact that the Petitioner had represented the matter but no decision was taken or communicated to the Petitioner.

Regard being had to the fact that the controversy involved in this case revolves round disputed question of facts and law, it is directed that in case fresh representation is submitted by the Petitioner, the same shall be decided within one month by passing a reasoned and speaking order which shall be communicated to the Petitioner within one month next thereafter.

It may be clarified that in case, the Petitioner is found entitled for promotion from Sept 1999 while deciding the representation so filed, he shall be given notional promotion attended with all consequential benefits.

In the above conspectus, we allow the T.A accordingly. However, this case shall not be construed to have been decided taking into consideration the merits of the case.
