There is delay of 03 months and 23 days in filing leave to appeal. Learned counsel for Union of India & Others has moved application for condonation of delay.</p> <p>4. Submission of learned counsel for the applicants-Chief of the Army staff & Others is that delay in filing leave to appeal is not deliberate. His further submission is that after passing of the order dated 17.03.2023 in T.A. No 64 of 2016, sometime has taken place in obtaining instructions from the respondents. Thus, his submission is that delay is not intentional, but for the reasons mentioned above and time taken by the department in processing the case for filing of the present application, delay of 03 months and 23 days is condonable in filing application for leave to appeal.</p> <p>5. We have gone through the affidavit filed in support of delay condonation application and find that the grounds and reasons shown in the accompanying affidavit for condonation of delay seem sufficient and therefore, delay in filing application is condoned. Delay condonation application stands disposed off.</p> <p><u>M.A. No 57 of 2024</u></p> <p>6. This application has been filed under Section 30 read with Section 31 of the Armed Forces Tribunal Act, 2007 against the judgment and order dated 17.03.2023 of this Tribunal passed in T.A. This execution application has filed for implementation of order dated 29.01.2021 passed in O.A. No. 264 of 2018. Despite grant of several opportunities, affidavit of compliance has not been filed by the respondents.</p> <p>3. Previous cost imposed on the respondents has not been deposited. Personal affidavit of Lt Col Mahendra Singh, Senior Record Officer, Artillery Records has been filed which is taken on record. In this affidavit status/progress of the execution has been mentioned and cause of delay has also been shown. In para 7 of the aforesaid affidavit, it is submitted that Govt sanction is awaited and in para 8 it is stated that Artillery Records vide its letter dated 10.01.2024 has approached AFT, Legal Cell for filing review application. It is also stated in this para that amendment is required to be done in order dated 29.01.2021 as the Tribunal vide order dated 29.01.2021 has granted war injury pension instead of liberalized family pension.</p> <p>4. After about three years from the date of order, respondents are approaching AFT Legal Cell for filing review application. Explanation furnished by the respondents for non compliance of the order of this Tribunal is not satisfactory, rather it indicates that there is intentional disobedience of the order of this Tribunal.</p> <p>5. Learned counsel for the respondents prays for and is granted six weeks further time on payment of additional cost of Rs 10,000/- for filing</p>

affidavit of compliance.

6. Respondents are also directed to deposit all the cost due against them till next date of listing which shall be remitted to the applicant. Respondents are further directed to show cause as to why contempt proceedings be not initiated against them for intentional disobedience of the order of this Tribunal. Respondents are also directed to show cause as to why property of the respondents be not attached for non compliance of the order.
