	on parole and he was released on parole for a period of 30 days vide this
	Tribunal order dated 23.03.2023.
	5. Brief facts of the case are that appellant was enrolled in the Indian Army
	on 04.06.2009. The appellant was detailed buddy of Lt Col ABC, PW-10 and
	looked after his daughter Miss XYZ who was about 8 years old. The appellant
	was charged on 19.11.2019 for repeatedly pinched and pressed the vagina of
	Miss XYZ, daughter of Lt Col ABC. The appellant was convicted by Summary
	General Court Martial (SGCM) and was sentenced with imprisonment for five
	years and dismissal from service for the offence under Army Act Section 69
	vide order dated 17.03.2021 and since then appellant is in jail.

Submission of learned counsel for the appellant is that appellant was

convicted and sentenced by SGCM on 17.03.2021 and appellant has already undergone more than 3 years of imprisonment against the punishment of 5 years. The mother of the appellant got paralyzed and is bed riddenand her daughter is under treatment for speech disorder for the last 5 years. In the absence of the appellant, there is no one to take care of his parents and family members who are now living in a pathetic condition. He placed reliance on the judgment of the Hon'ble Supreme Court in the case of Saudan Singh vs.State of U.P., Cr. Appeal No. 308/2022, decided on 25.02.2022, Kashmira Singh vs. State of Punjab, 1977 AIR 2147 and Prasanta Kumar Sarkar vs. Ashish Chatterji and another (2010) 14 SCC 496 and pleaded to release the appellant on bail as the appellant has already undergone more than 3 years of imprisonment against the award of 5 years.

- 7. Learned counsel for the respondents vehemently opposed the prayer of the bail and submitted that appellant has been convicted on serious offence under the POCSO Act. He further submitted that he is ready to argue the case on merit.
- 8. Heard learned counsel for the parties and perused the record.
- 9. In this case, appellant has been convicted and awarded 5 years imprisonment and dismissal from service. It is not disputed that appellant is in custody in this case for more than 3 years, i.e. more than half of the sentence awarded. There is no previous history of the appellant.
- 10. Considering the fact of the case, period of detention and no previous criminal history or bad conduct of the accused and the fact that final disposal of this appeal may take some time, there is sufficient ground to release the appellant on bail during the pendency of this Original Application (Appeal).
- 11. In view of above, the application for bail is allowed. The Appellant shall be released on bail forthwith on his furnishing a personal bond of Rs. 50,000/-(Fifty Thousand only) with two sureties in the like amount to the satisfaction of the Registrar of this Tribunal. On furnishing sureties, as stated above, Registrar shall then issue the release order, which in turn will be conveyed to the concerned Jail Superintendent, District Jail, Dhangri, Rajauri (J&K) wherein the appellant is presently confined and serving out his sentence. The appellant after release on bail shall attend Armed Forces Tribunal on each and every date of hearing. He shall not indulge in any criminal activity or commission of any crime after being released on bail. He shall surrender his passport (if any) and shall not leave the Country without the prior permission of this Tribunal where his case is pending. The appellant shall not cause any hindrance in pending proceedings and shall fully cooperate in peaceful hearing of the appeal. The appellant shall not leave the jurisdiction of this Tribunal without proper permission of the Tribunal. In case any complaint with regard to his conduct during the period of bail is received, the respondents will be free to

apply for cancellation of the bail granted by this Tribunal.

- 12. After release of the appellant, the bail bonds furnished for his release, shall be kept on record of this Original Application.
- 13. M.A. No 696 of 2024 stands disposed of accordingly.
- 14. List this case for hearing on Appeal on **21.11.2024**.
- 15. Let a copy of this order be provided to learned counsel for the parties for their necessary action and compliance.
