This application has been filed under Section 31 of the Armed Forces Tribunal Act, 2007 against the judgment and order dated 29.11.2022 of this Tribunal passed in Original Application No. 420 of 2022.</p> <p>3. There is a delay of 01 year, 04 months and 21 day in filing leave to appeal.</p> <p>4. Submission of Ld. Counsel for the applicants – Union of India & Others is that delay in filing leave to appeal is not deliberate. His further submission is that after the Judgment applicants sent the order to the JAG Department and Chief of Army Staff, New Delhi for obtaining legal opinion for compliance and after receiving legal opinion, higher authorities given instruction to file Leave to Appeal. Thus, his submission is that delay is not deliberate, but due to time taken by the department in processing the case for filing of leave to appeal.</p> <p>5. Having heard the submission of Ld. Counsel for the applicants – Union of India & others and considering the facts and circumstances of the case, we find that explanation offered by the applicants for delay in filing Leave to Appeal is not sufficient. It is settled in law that if time limit is given for filing of any application and the same is not filed within that time limit, delay should be explained on day to day basis which applicants have utterly failed in the present case.</p> <p>6. In the result, we find that delay is not condonable.</p> <p>7. Accordingly, delay condonation application is dismissed.</p> <p>8.
