On the case being taken up for hearing, Shri Vikas Chauhan, Ld. Counsel for the applicant and Dr. Chet Narayan Singh, Ld. Counsel for the respondents are present. Shri Rahul Pal, Advocate is not present.</p> <p>2. Objection has been filed on behalf of the respondents, which is taken on record.</p> <p>3. Heard learned counsel for the parties and perused the record.</p> <p><b><u>Ex-A/383 of 2023 Inre O.A. No. 53 of 2023</u></b></p> <p>4. This execution application has been filed by the applicant for implementation of order dated 23.03.2023 passed by this Tribunal in O.A. No 53 of 2023. This execution application was filed by Shri Rahul Pal, Advocate, who is not present today.</p> <p>5. Despite availing several opportunities, affidavit of compliance has not been filed by the respondents.</p> <p>6. Affidavit regarding present status of the case filed on behalf of the respondents is taken on record.</p> <p>7.
