	4. Second bail application has been moved by the appellant on 25.10.2024		
	before this Tribunal to release him on bail during pendency of his Original		

Application (Appeal) No. 79 of 2023 under Section 15 (3) read with 15 (6) of AFT

Act, 2007 and Rule 25 of the AFT (Procedure) Rules, 2008 for suspension of sentence awarded and to release the appellant on bail.

- 5. Brief facts of the case are that appellant was enrolled in the Indian Army on 12.02.2012. The appellant was detailed to perform buddy duty of Lt Col ABC at 510 Army Base Workshop. On 16.02.2020, the appellant forcefully hugged Miss XYZ and Miss GHI, daughters of Lt Col ABC and also groped the right breast of Miss XYZ while the officer and his wife were not present at their residence. A Court of Inquiry was convened on 20.02.2020 and General Officer Commanding Uttar Bharat Area directed disciplinary action against the accused. A FIR was also lodged against the appellant on 17.02.2020 under Section 354A of IPC and under Section 7 & 8 of POSCO Act 2012. By the order of GOC Uttar Bharat Area, General Court Martial (GCM) was convened and the appellant 'Guilty' of both the charges and sentenced him 'To suffer Rigorous Imprisonment for five years' and 'To be dismissed from service' and since then appellant is in jail. The appellant was released from jail on parole for a period of one month from 15.10.2024 to 14.11.2024 and surrendered back to the jail on due time on 14.11.2024.
- 6. Submission of learned counsel for the appellant is that appellant was convicted and sentenced by GCM on 14.05.2022. The appellant was kept under close arrest/military custody on 21.03.2022 and remained so during the entire trial proceedings by GCM. The appellant was lodged in Agra jail on 19.10.2022 and subsequently transferred to Central Jail, Kot Bhalwal, Jammu. The appellant has already undergone more than half, i.e. 2 years and 9 months of imprisonment against the punishment of 5 years. He pleaded to release the appellant on bail as the appellant has already undergone more than half of the imprisonment against the award of 5 years.
- 7. Learned counsel for the respondents vehemently opposed the prayer of the bail and submitted that appellant has been convicted on serious offence under the POCSO Act, hence, bail application of the appellant be rejected.
- 8. Heard learned counsel for the parties and perused the record.
- 9. In this case, appellant has been convicted and awarded 5 years imprisonment and dismissal from service. It is not disputed that appellant is in custody in this case for more than half of the sentence awarded to him. There is no previous history of the appellant.
- 10. Considering the fact of the case, period of detention and no previous criminal history or bad conduct of the accused and the fact that final disposal of this appeal may take some time, there is sufficient ground to release the appellant on bail during the pendency of this Original Application (Appeal).
- 11. In view of above, the second application for bail is **allowed.** The Appellant shall be released on bail forthwith on his furnishing a personal bond of Rs. 50,000/- (Fifty Thousand only) with one surety in the like amount to the

satisfaction of the Registrar of this Tribunal. On furnishing sureties, as stated above, Registrar shall then issue the release order, which in turn will be conveyed to the concerned Jail Superintendent, Central Jail, Kote Bhalwal, Jammu wherein the appellant is presently confined and serving out his sentence. The appellant after release on bail shall attend Armed Forces Tribunal on each and every date of hearing. He shall not indulge in any criminal activity or commission of any crime after being released on bail. He shall surrender his passport (if any) and shall not leave the Country without the prior permission of this Tribunal where his case is pending. The appellant shall not cause any hindrance in pending proceedings and shall fully cooperate in peaceful hearing of the appeal. The appellant shall not leave the jurisdiction of this Tribunal without proper permission of the Tribunal. In case any complaint with regard to his conduct during the period of bail is received, the respondents will be free to apply for cancellation of the bail granted by this Tribunal.

- 12. After release of the appellant, the bail bonds furnished for his release, shall be kept on record of this Original Application.
- 13. M.A. No 1209 of 2024 stands disposed of accordingly.
- 14. List this case for hearing on Original Application (Appeal) on 21.03.2025.
